### What are BTEC Nationals?

BTEC Nationals are Level 3 qualifications designed to provide highly specialist work-related qualifications in a range of vocational sectors.

They attract UCAS points that equate to similar-sized general qualifications within education institutions within the UK. On successful completion of a BTEC National qualification, you can progress to or within employment and/or continue your study in the same, or related vocational area.

### How you will be assessed

All assessment for BTEC Nationals is based on the achievement of specified assessment outcomes and learning aims. Each unit within the qualification has specified assessment and grading criteria which are to be used for grading purposes.

Types of assessment include:

- **Assignments** set and marked internally
- **Task** set and marked externally by Pearson
- Written exam set and marked externally by Pearson

Units are assessed using a grading scale of Distinction\*, Distinction, Merit, Pass and Unclassified.

In order to be awarded a qualification a you must complete all units and achieve a pass or above in all mandatory units unless otherwise specified,

To achieve any qualification grade, you must:

- complete and have an outcome (D, M P or U) for all units within a valid combination
- achieve the required units at pass or above
- achieve the **minimum number of points** at a grade threshold.

### What will I study?

#### **Edexcel BTEC Level 3 Extended Certificate**

The Edexcel BTEC Level 3 Extended Certificate in Business is a 360-guided-learning-hour (GLH) qualification that consists of 3 mandatory units plus 1 optional unit. 2 of the mandatory units are externally assessed. This qualification covers the key knowledge and practical skills required in the appropriate vocational sector and is broadly equivalent to one A Level. ### **Unit 1 – Exploring Business (Internal Assessment)**

- Internally assessed.
- You will study the purposes of different business, their structure and the effect of the external environment, and how they need to be dynamic and innovative to survive.
- You will gain an overview of the key ingredients for business success and how businesses are organised, including how to communicate.
- By developing their relevant business knowledge and understanding, you will be able to approach employment, vocational training and higher education head on.

- You will gain an understanding and design a marketing campaign for a selected business
- A scenario will be released by the exam board and you will be given preparation time before the assessment window.

- You will carry out in-depth investigation into the use of both personal and business finance.
- You will be introduced to accounting terminology and understand the purpose and importance of these to a business.
- You will also be able to analyse an existing businesses financial position, suggesting ways to improve.

#### TASK – Research and Create a series of Podcasts

#### 'Businesses impact and response to the coronavirus crisis.'

Many businesses in the UK have been effected by the current coronavirus crisis, some in a negative way and some in a positive way.

A key business term is 'external business factors', things which occur outside of the business, which they have no control over, yet have to respond to. Using this key business term and the current coronavirus crisis analyse how different businesses have been negatively and positively effected and also how they have adapted to respond to the crises in order to try and survive.

You then need to create a set of podcasts yourself to address the above, using real business examples.

What needs to be included in each podcast:

#### Podcast 1:

- 2. Identify and explain how these businesses have been positively affected (find at least 3)
  - **Business Name**
  - What they sell
  - The positive impact they have had
  - Any figures om the increase of their sales/revenue

- 2. Identify and explain how these businesses have been negatively affected (find at least 3)
  - **Business Name**
  - What they sell
  - The positive impact they have had

- 2. Research businesses who have been dynamic and adapted the way they operate in order to try and survive the crisis.( you should be able to find at least 2 examples)

EVALUATE	Learners draw on varied information, themes or concepts to consider aspects such as:  • strengths or weaknesses • advantages or disadvantages • alternative actions • relevance or significance.  Learners' enquiries should lead to a supported judgement showing relationship to its context. This will often be in a conclusion.
